**ORDINANCE NO. 2023-02**

**AN ORDINANCE OF LOWER PAXTON TOWNSHIP, AMENDING ORDINANCE NO. 07-08 RELATIVE TO THE REESTABLISHMENT AND MAINTENANCE OF TOWNSHIP EMPLOYEES PENSION, ANNUITY, INSURANCE AND BENEFIT FUND OR FUNDS, TO AMEND CERTAIN PROVISIONS OF THE PENSION PLAN OF PROGRAM APPLICABLE TO THE POLICE EMPLOYEES OF SAID TOWNSHIP**

**BE IT ORDAINED AND ENACTED** by the Board of Supervisors of Lower Paxton Township, Dauphin County, Pennsylvania (“Township”) and it is HERBY ORDAINED AND ENACTED by authority of same:

The Lower Paxton Township Police Pension Plan (“the Plan”), which was previously reestablished by Ordinance No. 07-08 for the benefit of the Township’s employees shall be, and hereby is, amended as set forth herein:

ARTICLE I FORMAT AND DEFINITIONS, Section 1.02 is amended to read as follows:

**Compensation** means the total remuneration of the Employee, whether salary or hourly wages including overtime pay, longevity pay, and service increments paid by the Employer for police services rendered. Compensation does not include the buy-back of unused accumulated sick leave or unused accumulated vacation leave or any one-time cash payments which are not associated with the Employee’s base pay. Compensation shall be limited on an annual basis to the amount specified for governmental plans pursuant to Code Section 401(a)(17), as adjusted under Code Section 415(d).

The above stated amendment shall become effective on January 1, 2023.

Any Ordinances, Resolutions or parts thereof which conflict with the provisions of this Ordinance shall be, and the same hereby are repealed so far as they shall affect this Ordinance; however, such repeal shall not affect any act done or any right or liability accrued under any such Ordinance or Resolution which shall be hereunder repealed or superseded and all such rights or liabilities shall continue and may be enforced in the same manner as if such repeal or supersession had not been made but only to the extent otherwise permitted under the laws of the Commonwealth of Pennsylvania.
