Brief Project Description: The Partnership for Hope would like to continue to offer critically-needed care, home items, baby needs, and other resources to Dauphin County's homeless, returning citizens, and other struggling people as they return to housing. We intend to build on existing partnerships with local shelters, transitional housing programs, our retail partners, community organizations and volunteers to solidify our distribution of over \$1,000,000 in basic needs annually and to extend use of sort facilities and a delivery truck to our volunteer teams and other non-profit organizations for the distribution of home and baby items, furniture, food, and other necessities. Our efforts in providing these basic needs are, whenever possible, joined with ongoing mentoring efforts that help struggling people emerge from cycles of poverty and dependence on public welfare programs.
