BOARD OF SUPERVISORS**

Minutes of Board meeting held May 19, 2021

A meeting of the Lower Paxton Township Board of Supervisors was called to order at 7:00 P.M. by Vice-Chairperson Lindsey on the above date at the Lower Paxton Township Municipal Center located at 425 Prince Street, Harrisburg, Pennsylvania.

Board members present in addition to Mrs. Lindsey, Chris Judd, Norman Zoumas, and Paul W. Navarro. Also in attendance were Bradley N. Gotshall, Township Manager, and Steve Stine, Township Solicitor.

Pledge of Allegiance

Mr. Navarro led the Pledge of Allegiance.

Approval of Minutes

Mr. Judd made a motion to approve the minutes of the meeting held on March 9, 2021. Mr. Zoumas seconded the motion. Mrs. Lindsey called for a voice vote, and there was a unanimous vote of approval.

Public Comment

There was none.

Announcements

Mrs. Lindsey announced that the Board of Supervisors met in executive session before the meeting, and they would meet again afterward.

Mr. Navarro recognized Carol Rudy an employee who worked at McDonald's on Rt. 22, for the last 20 years. Ms. Rudy was selected to go to Las Vegas and Italy, to represent McDonald's at the Special Olympics.

Mrs. Lindsey announced that she and Mr. Zoumas attended the Capital Region Council of Governments board meeting held on Monday, May 17, 2021. John Mosac of Dawood Engineering was the guest speaker. The topic of discussion was the impact of COVID-19 on Municipalities.

Manager's Report

Mr. Gotshall introduced Nicole Holmes, Codes Administrator in the Community Development Department. Ms. Holmes started working for the Township on May 10, 2021.

The Supervisors welcomed Ms. Holmes to the Township.

Action to Appoint Austin Gee to the Shade Tree Commission

Mr. Gotshall noted that the existing agreement with Approved Code Services expired on May 14, 2021, and they would like to renew this agreement for two years with no increase in fees.

Mr. Zoumas motioned to approve the renewal of an Agreement with Approved Code Services for Plan Review, Inspections, and Consulting Services. Mr. Navarro seconded the motion. Mrs. Lindsey called for a voice vote, and there was a unanimous vote of approval.

Subdivision and Land Development

Improvement Guarantees

Mr. Navarro made a motion to approve the Improvement Guarantees for 2717 English Court, SWMP 112 Memorial Drive, SWMP 131 Koch Lane, Goodall Pools and Spasm 6804 Blue Ridge Avenue, Kendale Oaks, Phase IV and Kendale Oaks, Phases II & III. Mr. Judd seconded the motion. Mrs. Lindsey called for a voice vote, and there was a unanimous vote of approval.

Payment of Bills – Lower Paxton Township & Lower Paxton Township

Mr. Zoumas motioned to approve the payment of bills for Lower Paxton Township and Lower Paxton Township Authority. Mr. Navarro seconded the motion. Mrs. Lindsey called for a voice vote, and there was a unanimous vote of approval.

Adjournment


