In June, Paxtonia 34 Fire Company added a 2019 Seagrave Rescue Engine to its fleet. The unit is designated as Engine 34-1. This addition marks a new era for the members of Paxtonia. The new Rescue Engine is equipped with several upgrades in technology and equipment. Lower Paxton Township and the Board of Supervisors are pleased to be able to fund the purchase of this new engine for Paxtonia Fire Company, in effort to provide the volunteer firefighters with the tools needed to do their job and keep Township residents safe.

PA state law prohibits the use of consumer fireworks (bottle rockets, roman candles, etc.) within 150 of an occupied structure or on public land.

In addition, Township Ordinance prohibits consumer fireworks after 10 pm or anytime on a property less than one acre. To report illegal fireworks, call 717-558-6900.

## Lower Paxton Township Parks System

Lower Paxton Township's Parks and Recreation Department works hard to provide leisure opportunities, activities and events for residents. Did you know that there are 16 public park facilities in Lower Paxton, covering approximately 382 acres of land?

Park facilities range from lightly developed forest and mountain land to established athletic fields, playgrounds and ball courts. There are six large parks that cover over 10 acres: Brightbill, George, Kohl, Koons, Lingle, & Wolfersberger. There are ten neighborhood parks (smaller than 10 acres): Centennial Acres, Forest Hills, Hocker, Hodges Heights, Hurley, Kings Crossing, Lamplight, Meadowbrook, Ranger, and Stray Winds.

In addition, the Township has several Greenway Trails, great for walking and exploring. A brochure highlighting the trail distances with brief descriptions is available on the Township website. The website also features a list of all the parks and the amenities offered at each one. The public can rent pavilions and ballfields through the Parks and Recreation Department.

## Notes from the Director of Public Safety Heat Preparedness Tips:

- » Heat waves can be dangerous and even life-threatening for people who don't take the proper precautions.
- » Most heat disorders occur because the victim has been overexposed to heat or has over-exercised for his or her age and physical condition. Older adults, young children, and those who are sick or overweight are more likely to succumb to extreme heat.
- » Before extreme heat occurs, it is important to take steps now to prepare:
  - Install window air conditioners snugly; insulate if necessary.
  - Check air conditioning ducts for proper insulation.
  - Weather-strip doors and sills to keep cool air in.
  - Cover windows that receive morning or afternoon sun with drapes, shades, awnings or louvers.
  - Keep storm windows up all year.
  - Know those in your neighborhood who might be most at risk to excessive heat and may need help.

## Dauphin County Local Share Municipal Grant Program

Dauphin County's Local Share Municipal Grant Program is now open and accepting applications.

If your organization is located in Lower Paxton Township and you wish to submit a grant application, please follow the proper steps to ensure your application is complete.

All non-municipal applicants are required to have letters of support/sponsorship from the eligible municipality in order to be considered for the program. Lower Paxton Township will hold a single meeting at a regularly scheduled Workshop of the Board of Supervisors in order to hear presentations by non-municipal applicants looking to submit a County application.

The Workshop Meeting will be held on **8/11/20 at 7:00 pm**. All organizations are asked to present to the Board and should have materials, including a project scope and application to the Township Manager by **Friday, 8/7/20**. After the August 11th Workshop Meeting, the Board will confer to rank all participating projects for which a request of support has been made. A resolution and final letter of support will be provided to each of the requested projects shortly after the 8/18/20 Board of Supervisors Business Meeting. At the 8/18/20 meeting, the Board will vote to adopt the resolution and ranking structure.

## Proper Discharge of Pool Water

Discharged pool water and waters containing chlorine or other chemicals can be detrimental to aquatic life if not handled responsibly. It is extremely important that these waters are handled correctly. Pool runoff must not enter our streams or be discharged to any storm sewer or land in which a storm sewer is accessible. Pool water runoff has the potential to cause fish kills and unsafe aquatic conditions.

The Pennsylvania Department of Environmental Protection (DEP) offers guidance on how to properly manage discharged pool water. Whether you are a private owner, manage a public pool, or work for a pool maintenance company, refer to these guidelines.

Help protect our streams and rivers by following these tips:

- Pool water may be disposed of through the sanitary sewer system ONLY with municipal permission. (Lower Paxton Township Authority allows pool water discharge into the sanitary sewer system)
- Never dispose of pool water through a storm sewer, which will discharge to a stream.
- If lowering the water level of the pool, let it drain to a lawn to prevent it from running off into a storm sewer.
- If a sanitary sewer system is not available, water may be used for irrigation if it does not run off the property or into a storm sewer. The discharge of swimming pool water to any Waters of the Commonwealth without a permit is a violation of the Clean Streams Law. Property owners and pool companies that violate this law may be prosecuted and penalized for damages.

## TNR in Lower Paxton Township

The Township is pleased to offer a feral cat voucher program (TNR - Trap Neuter and Release). This program allows residents to obtain a voucher for a 100% outside feral cat. Cats that are owned by a resident will not qualify. Feral cat management is critical to avoid massive colonies of cats. TNR prevents proliferation of cats and allows colonies to gradually shrink. As a part of this process, the resident is expected to be engaged and is expected to continue to feed the cats and provide reasonable water and shelter for them.

The vouchers are valid at No Body's Cats (in Mechanicsburg), PAWS (in Grantville), and Steelton Community Cats (in Steelton). The voucher qualifies for the spay/neutering of one cat, which includes a rabies vaccine and the tipping of one ear to identify that the cat has been processed. There is also a list of volunteers that can provide advice, training and support in humane trapping of feral cats. ### How the Process Works:

1. Sign up for an appointment at a clinic for TNR.
2. Once an appointment has been made, please contact the Lower Paxton Police Department with the appointment information and a voucher will be made available for the clinic location that you have chosen.


# Stormwater Program Update

## New Pole Building & Pipe Televising Equipment for Sanitary Sewer/Stormwater Programs

The Township Contractor, Ebersole Excavating, has completed the construction of the new 3,280 square foot Pole Building, located at the rear of the Sewer Operations Facility and Public Works Building on Locust Lane. The Pole Building will provide the needed additional storage space for the Municipal Separate Storm Sewer System (MS4) Program and provide additional storage for the Sewer and Public Works Department operations. The project was completed on budget at cost of \$371,625 and was shared between the Sewer and Stormwater Funds.



The Township has also received delivery of the new Aeries Televising Equipment. This sewer and stormwater televising system is equipped with specific components that allows the televising of large stormwater pipe as part of the MS4 program and a mainline lateral launching system to televise private sewers from the street, which is necessary for the DEP sewer replacement program. The project was completed on budget at cost of \$349,606 and was shared between the Sewer and Stormwater Funds. This equipment was purchased as a cost saving measure. Township crews will now be capable of performing the stormwater pipe televising, which has been determined to be more cost effective when compared to costs from private contractor bids.
